## The Good Life Rewards - Terms and Conditions

1. The lucky draw entitled "The Good Life Rewards" (the "Lucky Draw") is organized by YF Life Insurance International Ltd. (the "Organizer")
2. By participating in the Lucky Draw, a participant is deemed to have agreed to the corresponding terms and conditions.

### Eligible Participants

3. The Lucky Draw is open to individuals who fulfill all the following requirements (the "Eligible Participants" and each an "Eligible Participant"):
  - (a) he / she has attained the age of 18 when participating in the Lucky Draw ;
  - (b) he / she has received at least one dose of the COVID-19 vaccine under the COVID-19 Vaccination Program implemented by the People's Republic of China ("China") or the Hong Kong Special Administrative Region of the People's Republic of China ("Hong Kong") or the Macao Special Administrative Region of the People's Republic of China ("Macao") governments before the cut-off time of registration for entry to the Lucky Draw;
  - (c) he / she is a valid customer of YF Life Insurance International Ltd; and
  - (d) he / she has linked his/her in-force policy with YFLink, the service and information platform of YF Life.The Organizer has the discretion pursuant to these terms and conditions in determining whether any individual is an Eligible Participant, and the decision of the Organizer shall be final.
4. Employees and financial consultants of YF Life Insurance International Ltd. and their family members are not eligible to participate in the Lucky Draw.
5. Potential Eligible Participants are advised to consult their doctors and seek medical advice as to whether to receive any of the COVID-19 vaccinations. They shall have sole responsibility for such decisions.

7. Each Eligible Participant must, at the time of registration:
  - (a) provide his / her personal data including
    - (i) English name on the China / Hong Kong / Macau Identity Card
    - (ii) China / Hong Kong / Macau Identity Card number
    - (iii) Date of birth
    - (iv) Mobile phone number, and
    - (v) Email address
  - (b) declare and confirm that all of such personal information is accurate and complete.Eligible Participants will be disqualified if any personal data provided is inaccurate, incomplete or insufficient.
8. Registration for the Lucky Draw starts at 9:00 a.m. (Local time in Hong Kong / Macau) on 1<sup>st</sup> August 2021, and the cut-off time for registration of the Lucky Draw is 11:59 p.m. (Local time in Hong Kong / Macau) on 30<sup>th</sup> September 2021. Submission time is based on the time of receipt by the server of YF Life Insurance International Ltd.
